# Frequently Asked Questions

**Q:** Why did I receive a Notice of Violation?

**A:** Illegally Passing a School Bus Stopped For Boarding and Unboarding Children. The school bus was stopped on a roadway and operating the alternating flashing red lights with the stop arm extended. By law, the driver of another vehicle meeting or overtaking the school bus may not proceed until the school bus resumes motion or **the alternating flashing red lights and or stop arm are deactivated.**

**Q:** Will this be reported to my insurance or go against my driving record?

**A:** No. This is a civil penalty, much like a parking ticket. The owner of a motor vehicle shall be liable for a civil monetary penalty if such vehicle is found, as evidenced by recorded images, to have been operated in disregard or disobedience of subsection (a) of Georgia Code 40-6-163 and such disregard or disobedience was not otherwise authorized by law.

**Q:** How much is the fine?

**A:** The amount of the fine is **\$250.00**

**Q:** How do I contest a violation?

**A:** To request a hearing, sign the NOTICE TO CONTEST (Dispute/Appeal the Citation) in SECTION II of the reversed side of this document and mail it to: Violation Processing Center, PO Box 22091, Tempe, AZ 85285-2091. You will receive a hearing date in the mail with the date, time, and location of your court date.
